To All Whom These Presents May Concern:

I, John T. Booker, of Greenville County,

SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Six Thousand, Nine Hundred and No/100 - - - - -

(\$ 6,900.00) Dollars, with interest at the rate specified in said note, to be repaid in installments of

Forty-Three and 66/100 - - - - - (\$ 43.66)

Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, City of Greenville, known as Lot Number 1 on a plat of the property of J. H. Lenhardt prepared by J. C. Hill, Registered Surveyor, dated February 28, 1953, the said plat being of record in Plat Book FF, at page 192, and recorded in the office of the Register of Mesne Conveyances for Greenville County, the said lot being more particularly described as follows:

"BEGINNING at an iron pin on the West side of Hall Street (Palm Street) at joint lot corner 1 and 2, and running S. 76-30 W., 113.3 feet to an iron pin at the rear line of the Lenhardt property; thence S. 3-49 E., 60 feet to an iron pin; thence N. 70-45 E., 112 feet to an iron pin on Hall Street (Palm Street) as shown on the plat; thence along Hall Street (Palm Street), N. 10-15 E., 50 feet to the point of beginning, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.

"The above described property is the same conveyed to John T. Booker and Estelle Booker by J. H. Lenhardt by deed dated June 16, 1954 and recorded in the R. M. C office for Greenville County in Vol. 501, at page 423, the said Estelle Booker having conveyed her undivided one-half interest in said property to John T. Booker by deed of even date herewith, not yet recorded."
