SEND GREETINGS.

VILLE, in the full and just sum of Four Thousand, Two Hundred and No/100

(\$4,200.00) Dollars, with interest at the rate specified in said note, to be repaid in installments of

Forty-Two and No/100 (\$42.00) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum,
