TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Wash R. Brown

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Four Thousand and No/100- - - - -

DOLLARS (\$4,000.00), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Wilbanks Street in Greenville Township, being shown as Lot 17 on plat of the property of I. Saul recorded in Plat Book "F" at Page 246 and having according to said plat the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southern side of Wilbanks Street at the joint front corner of Lots 17 and 19 and running thence with the line of Lot 19 S. 10-15 E. 155.4 feet to an iron pin at rear corner of Lot 16; thence with the rear line of Lot 16 N. 78-50 E. 60 feet to an iron pin at the rear corner of Lot 15; thence with the line of Lot 15 N. 10-15 W. 154.5 feet to pin on Wilbanks Street; thence with the southern side of Wilbanks Street S. 79-45 W. 60 feet to the point of beginning."

Being the same premises conveyed to the mortgagor by T. J. Bentley by deed to be recorded.
