TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, **Claude E. McMillan**, of the County of Greenville, State of South Carolina, SEND GREETING:

WHEREAS, I, the said **Claude E. "All that lot of land in Greenville County, State of South Carolina, situate on the West side of State Highway 101 leading from Greer to Gilreath's Mill in O'Neal Township, designated as lots 3, 4 and 8 on plat of the property of S. S. Mason according to survey made by J. C. Bruce dated February 28, 1950, also shown as lots 56, 57 and 61 on Block 1, on page T-20 of the County Block Book, and when described as a whole has the following metes and bounds, to-wit:
