(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Five Thousand and No/100- - - - -

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, known and designated as lot No. 123 of Belmont Heights, a subdivision surveyed by C. C. Jones, Engineer, and having according to a plat made by C. C. Jones, the following metes and bounds, to-wit:

"BEGINNING at a pin on the Northern side of Melvin Drive, and running thence with the Northern side of Melvin Drive, S. 53-31 W. 83 feet to a pin, and S. 13-26 W. 83 feet to a pin; thence N. 5-35 E. 253.5 feet to a pin; thence S. 41-23 E. 263.5 feet to the beginning corner. This lot is roughly triangular in shape."
