"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northwest side of Abelia Road, near the City of Greenville, being shown as Lot 2 on plat of Section 1, Garrison Circle, made by Beeson and Scott, Surveyors, October 1952, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "CC", at page 36, said lot fronting 120.94 feet along the Northwest side of Abelia Road, and running back to a depth of 85 feet on the Northeast side, to a depth of 100 feet on the Southwest side and being 120 feet across the rear.
