SEND GREETING:

Whereas, I, the said **Ella P. Groce**
 in and by **my** certain **promissory** note in writing, of even date with these
 Presents, **am** well and truly indebted to **E. H. Edwards**

in the full and just sum of **Five Hundred Twenty-five and no/100 Dollars**
(\$525.00), to be paid **twelve months from date hereof**

together with interest thereon from **date**

at the rate of **7** per centum per annum, to be computed and paid **at maturity**

until paid in full: all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said

E. H. Edwards, his Heirs and Assigns forever, the following described real estate:

ALL that piece, parcel or lot of land, with improvements thereon, situated in Chick Springs Township, School District 285, said County and State, lying on the South side of the Super Highway (U.S. Highway No. 29), containing fourteen (14) acres, more or less, being the remainder of the five (5) acre tract and the 22 acre tract, conveyed to me by J. William Peterson, Jr., under the Will of T. M. Groce, by deed dated July 8th, 1939, and recorded in the RMC Office for said County in Deed Book 212 at Page 111, lying South of said Super Highway and bounded as follows: North by said Super Highway; East and Southeast by branch, South and Southwest by lands of I. P. Few and West by Jones Road.
