Jones, S. 65-13 W. 169 feet to an iron pin; thence with the line of Lot 4, N. 31-24 W. 211.4 feet to an iron pin on the southeast side of the Greer-Brushy Creek Road; thence along said road, N. 58-21 E. 68 feet to an iron pin; thence continuing along the southeast side of the Greer-Brushy Creek Road, N. 50-50 E. 100 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
