with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid: \$25.00 per month until paid in full with interest thereon from date at the rate of six (6%) per cent. per annum, to be computed and paid semi-annually in advance

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, containing 2.24 acres, more or less, as per plat by R. E. Hiller, September 1938, and described as follows:

"BEGINNING at an iron pin in the center of Mill Road, joint corner of Bell View School property, and running thence S. 0-25 E. 17 feet to an iron pin on the edge of said road; thence S. 0-25 635.6 feet to an iron pin in a farm road; thence along center of said road, S. 65-22 W. 216 feet to an iron pin in center of said road; thence N. 0-25 W. 800 feet along line of Nelle Barnette property to iron pin on edge of Mill Road; thence N. 0-25 W. 18 feet to iron pin in center of said Mill Road; thence along center of said road, S. 69-15 E. 210 feet to the beginning."
