in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to us in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Peoples National Bank of Greenville, S. C., its successors and assigns forever:

All that certain piece, parcel or lot of land in Greenville County, State of South Carolina, being known and designated as Lot #6 on a plat of property of W. E. McClain, made by W. J. Riddle, Surveyor in April, 1950, and recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book "X", Page 459, and having according to said plat the following metes and bounds:

BEGINNING at the joint front corner of Lots Nos. 5 and 6, and running thence with the joint line of said lots, N. 74-50 E. 171.5 feet to an iron pin, joint rear corner of Lots Nos. 5 and 6; thence N. 14-03 W. 63 feet to an iron pin on new cut road; thence N. 87-10 W. 176.2 feet to an iron pin, corner of two new cut roads; thence along the line of said other new cut road, S. 13-40 E. 114 feet to point of beginning.
