ALL that piece, parcel or lot of land in the County of Greenville, State of South Carolina, being known and designated as the greater portion of Lot No. 6 of the property of Conestee as shown on plat thereof made by R. E. Dalton, Engr., December 1943 and recorded in the RMC Office for Greenville County in Plat Book "K", at page 276.

BEGINNING at a point on the South side of Fourth Avenue, which point is 10 feet from the joint front corner of Lots 6 and 7 and running thence with the South side of Fourth Avenue, South 61-20 East 75 feet to the joint corner of Lots 4 and 5; thence with the line of lots 3 and 4, South 50-20 West 107.6 feet to the joint rear corner of Lots 6 and 3; thence with the line of Lot 2, North 61-20 West 45 feet to the joint corner of Lots 6 and 7; thence with the new line in a Northeasterly direction 175 feet more or less, to the point of beginning and being all of Lot No. 6 except a 10-foot strip which is triangular in shape.
