To All Whom These Presents May Concern: We, Harold B. Powers and Carolyn L. Powers,

the Mortgagor(s), SEND GREETING:

All of that parcel or lot of land in Chick Springs Township of Greenville County, South Carolina, near the limits of the City of Greer and northward therefrom, being designated as Lot No. 17 of a subdivision known as "Pinebrook", according to survey and plat thereof by H.S. Brockman, Registered Surveyor, dated February 21, 1955, and having the following courses and distances:
