To All Whom These Presents May Concern

I, Evelyn H. Suttles,
hereinafter spoken of as the Mortgagor send greeting.

Whereas Evelyn H. Suttles

is justly indebted to C. Douglas Wilson & Co., a corporation organized and existing under the laws of the State of South Carolina, hereinafter spoken of as the Mortgagee, in the sum of Sixteen Thousand and no/100

Dollars

(\$ 16,000.00), lawful money of the United States which shall be legal tender in payment of all debts and dues, public and private, at the time of payment, secured to be paid by that one certain note or obligation, bearing even date herewith, conditioned for payment at the principal office of the said C. Douglas Wilson & Co., in the City of Greenville, S. C., or at such other place either within or without the State of South Carolina, as the owner of this obligation may from time to time designate, of the sum of

Sixteen Thousand and no/100

Dollars (\$ 16,000.00)

with interest thereon from the date hereof at the rate of 5 per centum per annum, said interest to be paid on the 1st day of April 19 55 and thereafter said interest and principal sum to be paid in installments as follows: Beginning on the 1st day of May 19 55, and on the 1st day of each month thereafter the sum of \$ 105.60 to be applied on the interest and principal of said note, said payments to continue up to and including the 1st day of March 19 75, and the balance of said principal sum to be due and payable on the 1st day of April 19 75. The aforesaid monthly payments of \$ 105.60 each are to be applied first to interest at the rate of 5 per centum per annum on the principal sum of \$ 16,000.00 or so much thereof as shall from time to time remain unpaid and the balance of each monthly payment shall be applied on account of principal. Said principal and interest to be paid at the par of exchange and net to the obligee, it being thereby expressly agreed that the whole of the said principal sum shall become due after default in the payment of interest, taxes, assessments, water rate or insurance, as hereinafter provided.

Now, Know All Men, that the said Mortgagor in consideration of the said debt and sum of money mentioned in the condition of the said note and for the better securing the payment of the said sum of money mentioned in the condition of the said note with the interest thereon, and also for and in consideration of the sum of One Dollar in hand paid by the said Mortgagee, the receipt whereof is hereby acknowledged, has granted, bargained, sold, conveyed and released and by these presents does grant, bargain, sell, convey and release unto the said Mortgagee and to its successors, legal representatives and assigns, forever, all that parcel, piece or lot of land with the buildings and improvements thereon, situate, lying and being at the Southwesterly corner of the intersection of Batesview Drive and Primrose Lane, in the City of Greenville, S. C., being shown as Lot No. 23 on the plat of Northside Gardens as recorded in the RMC Office for Greenville County, S. C. in Plat Book "S", page 17, and having according to a survey made by Douglas S. Crouch, dated March 28, 1955, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwesterly side of Batesview Drive, at the Southwesterly intersection of said Drive with Primrose Lane, and running thence along the Southwesterly side of Batesview Drive S 23-26 E 60 feet to an iron pin, joint front corner of Lots Nos. 22 and 23; thence along the joint line of Lots Nos. 22 and 23 S 69-14 W 189.2 feet to an iron pin in the line of Lot No. 24; thence along the line of Lots Nos. 23 and 24 N 25-41 W 125.3 feet to an iron pin on the Southerly side of Primrose Lane; thence along the Southerly side of Primrose Lane N 80-45 E 175 feet to an iron pin at the intersection of said Lane with Batesview Drive; thence around said intersection on a curve, the chord of which is S 61-20 E 39.4 feet to the point of beginning.
