(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

EIGHT THOUSAND FIVE HUNDRED

DOLLARS (\$ 8,500.00 ), with interest thereon from date at the rate of Five

per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, on the northwest side of the Hammett Bridge Road and about two miles southwest of the City of Greer, near the Pleasant Grove Baptist Church, being a part of Tract No. 9 of the John G. Greer Estate, according to a survey and plat thereof made by H.S. Brockman, Surveyor, and having the following courses and distances:

BEGINNING on a nail & stopper in the center of said Hammett Bridge Road, and runs thence with said road N. 59.10 E. 200 feet to a nail & stopper (iron pins on the bank of the road at both corners); thence the new line N. 45.00 W. 26 feet to iron pin on the bank of the road; thence continuing same course for a total of 300 feet to a stake or iron pin; thence S. 59.10 W. 200 feet to a point in the new road (stake or iron pin on bank thereof at 15 feet); thence with the new road S. 45.00 E. 300 feet to the beginning corner, containing 1.34 acres, more or less, and being all of that property conveyed to the mortgagors herein by deed from W.O. Holliday, recorded in the R.M.C. Office for Greenville County in Deed Book 465, at page 497.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
