All that certain piece, parcel or lot of land, with the buildings and improve-
ments thereon, lying and being on the Westerly side of West Decatur Street, near the
City of Greenville, S. C., and being shown as Lot No. 83 on the plat of J. P.
Rosamond as recorded in the REC Office for Greenville County, S. C. in Plat Book "H",
pages 185 and 186, said lot fronting 60 feet on the Westerly side of West Decatur
