four and one-half per centum ($4\frac{1}{2}\%$) per annum until paid, said principal and interest being payable
at the office of C. Douglas Wilson & Co.

in Greenville, South Carolina , or at such other place as the holder of the note may
designate in writing delivered or mailed to the Mortgagor, in monthly installments of - - - - -
Forty-Seven & 25/100- - - - - Dollars (\$ 47.25), commencing on the first day of
June , 19 55 , and continuing on the first day of each month thereafter until the principal and
interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and
payable on the first day of May , 19 80 .

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the
payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor
in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt
whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does
grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described
property situated in the county of Greenville
State of South Carolina;

All that piece, parcel or lot of land, with the buildings and improvements
thereon, situate, lying and being near the City of Greenville, in the County
of Greenville, State of South Carolina, being known and designated as Lot No.
9 on plat of North Acres, as per plat thereof recorded in the R.M.C. Office
for Greenville County, South Carolina, in Plat Book "EE", pages 12 and 13,
and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin in the curve of Neal Circle on the Northeasterly side
and at the joint front corner of Lots 9 and 10 and running thence N. 25-46 E.
140.1 feet to an iron pin; thence S. 79-10 W. 156.5 feet to an iron pin; thence
S. 10-50 E. 100 feet to an iron pin on the Northerly side of Neal Circle, joint
front corner of Lots 8 and 9; thence along the Northerly side of Neal Circle,
N. 79-10 E. 50 feet to an iron pin; thence around the curve of Neal Circle,
the chord of which is S. 72-51 E. 25.8 feet to an iron pin, the point of
beginning.

the following described household appliances, which are and shall be deemed to be, fixtures and a part of the realty
and are a portion of the security for the indebtedness herein mentioned;
