COUNTY OF GREENVILLE) EXTENSION AGREEMENT

WHEREAS, on the ^{2nd} ~~24th~~ day of ^{May} ~~March~~, 1955, First Federal Savings and Loan Association of Greenville made a loan to R. N. Church in the sum of Thirty-Eight Hundred (\$3800.00) Dollars, with payments thereon at the rate of Thirty-Eight (\$38.00) Dollars per month, with interest at the rate of six (6%) per centum per annum; and

WHEREAS, it is desired that said payments be reduced to Thirty-Two and 07/100 - (\$32.07) Dollars per month, with interest at the rate of six (6%) per centum per annum. Now therefore,

KNOW ALL MEN BY THESE PRESENTS that in and for the mutual consideration of the premises hereinabove stated, the First Federal Savings and Loan Association of Greenville agrees that should the mortgagor, R. N. Church, make the payments on the note and mortgage hereinabove set out in the sum of Thirty-Two and 07/100 - (\$32.07) Dollars per month that the said loan shall not be considered delinquent by reason of the fact that the executed mortgage calls for monthly payments of Thirty-Eight (\$38.00) Dollars each, it being the intention of this agreement to extend the term of the mortgage from eleven years, 7 months to fifteen years.

Should the said R. N. Church fail to make the payments in the lesser amount of Thirty-Two and 07/100 - (\$32.07) Dollars per month, the Association may declare the whole amount of said note and mortgage due and payable. Changing the rate of monthly payments of the aforesaid loan does not change in any respect any of the other terms of the aforesaid note and mortgage.
