ALL that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, near Judson Mill and being known as the Northern part of Lot No. 1 on plat of lands of J. O. Heatherly as recorded in the RMC Office for Greenville County in Plat Book "E", at page 235 and having the following metes and bounds:

BEGINNING at an iron pin on the South side of the right-of-way of Southern Public Utility Company and corner of Judson Mill property and running thence with the line of Judson Mill property, S. 49-59 West 180.4 feet to a stake corner of other property of J.O.
