WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Thirteen Hundred Fifty Two and 89/100- - - - -

DOLLARS (\$ 1352.89 ), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, on the Eastern side of 4th Street (formerly Whitney Street, formerly Hoover Street), at Slater, S. C. being shown as lot # 6 of Block B, on plat of the village of S. Slater & Sons, made by J. E. Sirrine on July 10, 1940, and recorded in Plat Book K at Pages 63, 64 and 65, and described as follows:

"BEGINNING at a stake on the Eastern side of Fourth Street, at corner of lot No. 5, and running thence with the line of said lot, S. 85-37 E. 125.85 feet to a stake; thence N. 13-46 E. 44.1 feet to a stake, corner of lot No. 7; thence with the line of said lot, N. 66-52 E. 125 feet to a stake on Fourth Street; thence with the Eastern side of Fourth Street, S. 14-24 W. 85 feet to the beginning corner, said premises being the same conveyed to the mortgagor by S. Slater & Sons, Inc., by deed dated October 1, 1940, recorded in Book of Deeds 227 at Page 16."
