TO ALL WHOM THESE PRESENTS MAY CONCERN:

Greenville Home Builders (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto **Citizens Lumber Company** (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Ten Thousand and No/100 - - -**

DOLLARS (\$ 10,000.00),

with interest thereon from date at the rate of **six (6%)** per centum per annum, said principal and interest to be repaid: in **monthly installments of \$100.00 each, beginning on June 20, 1955, and a like payment of \$100.00 on the 20th day of each month thereafter, to be applied first to interest then to principal, with interest thereon from date at the rate of six (6%) per cent. per annum, to be computed semi-annually and paid monthly**

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of **Three (\$3.00) Dollars** to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of **Mills Avenue near the City of Greenville, being shown as Lot No. 4 on a plat of Kirkwood Heights recorded in Plat Book "EE" at Page 110, and described as follows:**

"BEGINNING at a stake on the northern side of Mills Avenue 240 feet east from Edgewood Drive at corner of Lot 3 and running thence with the line of said lot N. 17-56 W. 150 feet to a stake at corner of Lot 22; thence with the line of said lot N. 72-04 W. 80 feet to a stake at corner of Lot 5; thence with the line of said lot S. 17-56 E. 150 feet to a stake on Mills Avenue; thence with the northern side of said avenue S. 72-04 W. 80 feet to the beginning corner."

Being the same premises conveyed to the mortgagor by W. K. Stringfellow and C. L. Tidwell by deed to be recorded herewith.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
