TO ALL WHOM THESE PRESENTS MAY CONCERN:

W. HUBERT ALFORD (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note dated May 21, 1955, the terms of which are incorporated herein by reference in the sum of Six Thousand and No/100 DOLLARS (\$ 6,000.00), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northwest side of Tipperary Lane, near the City of Greenville, being shown as the Southwestern 20 feet of Lot 9 of Block C, on plat of Mayfair Estates, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "S", at pages 72 and 73, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwest side of Tipperary Lane at joint front corner of Lots 9 and 10, and running thence with the line of Lot 10, N. 60-48 W. 150 feet to an iron pin; thence N. 29-12 E. 20 feet to an iron pin; thence through Lot 9, S. 60-48 E. 150 feet to an iron pin on the Northwest side of Tipperary Lane; thence along the Northwest side of Tipperary Lane S. 29-12 W. 20 feet to the beginning corner.

This is a portion of the property conveyed to the Mortgagor herein by deed of Roy L. Sisk and Helen P. Sisk, recorded in the R. M. C. Office for Greenville County, S. C.

The note above mentioned is also secured by my mortgage given to Fidelity Federal Savings and Loan Association, Greenville, S. C., dated May 21, 1955, recorded in the R. M. C. Office for Greenville County, S. C., in Mortgage Book 638, at page 473, which covers the lot adjacent to that above described.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
