WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

DOLLARS (\$ 15,000.00), with interest thereon from date at the rate of Six (6%)
per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Eastern side of Galphin Drive, being shown as Lot No. 2 on property of John G. Wilson, recorded in Plat Book W at Page 163, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Eastern side of Galphin Drive at the joint front corner of Lots 1 and 2, and running thence with line of Lot 1, S. 58-08 E. 168.7 feet to pin in line of Lot 3; thence with line of Lot 3 N. 29-56 E. 102.3 feet to pin on Cyrus Court; thence with the Southern side of Cyrus Court N. 49-14 W. 14.2 feet to pin; thence continuing with the Southern side of Cyrus Court, N. 60-09 W. 119.2 feet to pin; thence with the curve of the intersection of Cyrus Court and Galphin Drive, the chord of which is S. 77-51 W. 37.1 feet to pin on Galphin Drive; thence with the Eastern side of Galphin Drive S. 35-51 W. 75 feet to the point of beginning.

Said premises being the same conveyed to the mortgagors by deed of John G. Wilson to be recorded herewith.
