(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FOUNTAIN INN FEDERAL SAVINGS AND LOAN ASSOCIATION OF Fountain Inn, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by

reference, in the sum of Seven Thousand Two Hundred Fifty and no/100

DOLLARS (\$ 7,250.00), with interest thereon from date at the rate of six per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Fairview Township, being approximately 2 miles north of the town of Fountain Inn on the east side of Jones Mill Road containing 2.98 acres according to a plat made for Charles G. Garrett by J. C. Hill dated May 22, 1951 and being more fully described according to said plat, to-wit:

Beginning at an iron pin on the east side of Jones Mill Road, joint corner of property of Charles G. Garrett and Blake P. Garrett and running thence S 67-35 E, 338.5 feet to an iron pin; thence N 23-05 E, 517.8 feet to an iron pin; thence S 73-30 W, 428 feet to an iron pin on the eastern side of Jones Mill Road; thence running along Jones Mill Road, S 23-20 W, 250.7 feet to an iron pin, being the point of beginning, said property being bound on the west by Jones Mill Road, on the south and east by property of Blake P. Garrett and on the north by property of Clarence and Furman Sims.

Said property being the same as conveyed the mortgagor by deed of Charles G. Garrett dated June 15, 1955 and to be recorded in the R.M.C. Office for Greenville County.
