SEND GREETINGS:

Whereas, I the said E. Paul Foster
in and by my certain promissory note in writing, of even date with these presents, am (are) well and truly indebted to
HOME BUILDING & LOAN ASSOCIATION, Easley, South Carolina,
in the full and just sum of Thirty-five Hundred and No/100 - - - Dollars,
(\$ 3500.00) payable at the offices of said Association at Easley, South Carolina, with interest at the rate of Six per centum
(6%) per annum, to be repaid in installments of Thirty-five and No/100 - - - (\$ 35.00)
Dollars, due and payable upon the first day of each and every calendar month hereafter until the full principal sum with interest
has been paid, said monthly installment to be applied first to the payment of interest, computed monthly on the unpaid balance, and
then to principal; all interest, not paid when due to bear interest at same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the
option of the holder thereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's
fee of ten per cent, besides all costs and expenses of collection, to be added to the amount due on said note and to be collectible
as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected
by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note,

, in consideration of the said debt and sum of money
aforesaid, and for the better securing the payment thereof to the said HOME BUILDING & LOAN ASSOCIATION, Easley, South
Carolina, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me , the said

, in hand and truly paid by the said HOME BUILDING & LOAN ASSOCIATION, Easley,
South Carolina, at and before the signing of these Presents, the receipts whereof is hereby acknowledged, have granted, bargained,
sold and released, and by these Presents do grant, bargain, sell and release unto the said HOME BUILDING & LOAN ASSOCIA-
TION, Easley, South Carolina, its successors or assigns:

All that certain piece, parcel or lot of land in the State of South Carolina,
County of Greenville, on the eastern side of Whitney Street being shown and designated
as Lot 6, Block "A", on plat of S. Slater and Sons, recorded in Flat Book "K" at
Pages 63, 64, and 65, and also the lot to the rear of said lot being shown on plat
recorded in Flat Book "DD" at Page 121, and when described as a whole, has the following
metes and bounds, to-wit:

"BEGINNING at an iron pin at the southeastern corner of the intersection of Edison
Street and Whitney Street and running thence with Edison Street N. 60-04 E. 253.35 feet
to pin; thence S. 2-27 E. 99.5 feet to pin; thence S. 60-18 W. 242.82 feet to pin on
Whitney Street; thence with the eastern side of Whitney Street N. 8-01 W. 95 feet to
the point of beginning."
