TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Mrs. Mae Dill

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

ONE HUNDRED TEN  
 DOLLARS (\$ 110.00 ), with interest thereon from date at the rate of Seven  
 per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greer, Chick Springs Township, located on Franklin Street Extension, being all of that lot of land conveyed to me, the mortgagor, by James M. Cason and Annie Mae Cason by deed dated August 18, 1953, recorded in the R.M.C. Office for Greenville County in Deed Book 484, at page 245, and having the following courses and distances: BAGINNING on the corner of lot now owned by Dora Johnson, and runs thence in a southerly direction 75 feet, more or less, to property formerly owned by Franklin Mills; thence in an easterly direction 85 feet, more or less, to a stake on street; thence in a northerly direction 75 feet, more or less, to stake on Dora Johnson's line; thence in a westerly direction  $78\frac{1}{2}$  feet, more or less, to the beginning corner.

This mortgage is in addition to mortgages heretofore given by me to the mortgagee herein, all of which remain in full force and effect.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fixed thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
