All of that parcel or tract of land in Highland Township of Greenville County, South Carolina, located on the West side of the Greer-Highland Road, about 11 miles North from the City of Greer, being shown as Tract No. 1 on a plat of property made for the Planters Savings Bank of Greer, S.C., made by H.S. Brockman, Surveyor, dated March 13, 1935, less a tract convyed therefrom by O.M. Barton to Walter Slatton by deed recorded in the R.M.C. Office of Greenville County in Deed Book 180, at page 136, the entire tract having the following courses and distances:
