Floyd A. Fields & Annie N. Fields (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 57, Block A, as shown on a plat of City View, recorded in Plat Book A at Pages 460 and 461, and described as follows:

BEGINNING at an iron pin in the East side of Henderson Street, joint front corner of Lots 56 and 57, and running thence S. 89-30 E. 150 feet to an iron pin in line of Lot 1; thence with line of said lot, N. 00-30 E. 50 feet to rear corner of Lot 58; thence with line of said lot, N. 89-30 W. 150 feet to an iron pin in East side of Henderson Street; thence with said Street, S. 00-30 W. 50 feet to the point of beginning.

Being the same property conveyed to the mortgagors by deed recorded in Deed Book 498 at Page 424.
