MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Marcus J. Holcombe,

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto J. L. Love

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of One Thousand Five Hundred and No/100 - - - DOLLARS (\$ 1,500.00),

with interest thereon from date at the rate of six per centum per annum, said principal and interest to be repaid:

On Demand, with interest thereon from date at the rate of six (6%) per cent, per annum, to be computed and paid quarterly,

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Western side of Maco Terrace, near the City of Greenville, being shown as Lot No. 38 on Plat of property of Central Realty Corporation, as revised by Pickell & Pickell on May 31, 1946, recorded in Plat Book P, at page 51, and described as follows:

BEGINNING at a stake on the Western side of Maco Terrace at corner of Lot No. 29-A, and running thence with the line of said lot, S. 54-03 W. 145 feet to a stake; thence S. 36-05 E. 90 feet to a stake at corner of Lot No. 31-A; thence with the line of said lot, N. 54-03 E. 145 feet to a stake on Maco Terrace; thence with the Western side of Maco Terrace, N. 36-05 W. 90 feet to the beginning corner.

The above described property is the same conveyed to the Mortgagor by Deed recorded in the R.M.C. Office for Greenville County in Deed Book 371, at page 439.

ALSO, all that certain piece, parcel or lot of land in Greenville County, State of South Carolina, at the Northern corner of First Avenue and C Street, near the City of Greenville, being shown as Lot No. 44 on a Plat of Section 1 of F. W. Poe Mfg. Co., made by Dalton & Neves in July 1950, recorded in Plat Book Y, at pages 26-31, and described as follows:

BEGINNING at a stake at the Northern corner of First Avenue and C Street, and running thence with the Northwestern side of C Street, N. 49-00 E. 73 feet to a stake at corner of Lot No. 43; thence with the line of said lot, N. 40-36 W. 84.3 feet to a stake in line of Lot No. 42; thence with the line of said lot, S. 49-00 W. 73 feet to a stake on First Avenue; thence with the Northeastern side of said Avenue, S. 40-36 E. 84.3 feet to the point of beginning.

The above described property being the same conveyed to the Mortgagor by Deed recorded in the R.M.C. Office for Greenville County in Deed Book 419, at page 170.

ALSO, all that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, known and designated as Lot No. 4, Block K, of Fair Heights, as shown on Plat recorded in Plat Book F, at page 257, and having, according to said Plat, the following metes and bounds, to-wit;

BEGINNING at a point on the Western side of Cumberland Avenue, at the joint front corner of Lots Nos. 3 and 4, and running thence along the line of Lot No. 3, N. 58-40 W. 140 feet to a point at the joint rear corner of Lots Nos. 21 and 22; thence along the rear line of Lot No. 21, S. 31-20 W. 50 feet to a point at the joint rear corner of Lots Nos. 20 and 21; thence along the dividing line of Lots Nos. 4 and 5, S. 58-40 E. 140 feet to point on the Western side of Cumberland Avenue; thence along the Western side of Cumberland Avenue, N. 31-20 E. 50 feet to the beginning.

The above described property being the same conveyed to the Mortgagor by Deed recorded in the R.M.C. Office for Greenville County in Deed Book 354, at page 166.
