I, Lily McCauley Loftis

the Mortgagor(s), SEND GREETING:

BEGINNING at a stake, corner of Brannon Avenue and Lanford Street, and running thence with Lanford Street N. 17-40 E. Sixty (60) feet to a stake; thence S. 72-20E, one hundred fifty (150) feet to a stake; thence S. 17-40 W. Sixty (60) feet to a stake on said Brannon Avenue; thence with Brannon Ave. N. 72-20 W. one hundred fifty (150) feet to the beginning corner, same being lot #29 on a plat of land known and designated as Westmoreland Circle.
