WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in the City of Greenville, on the Southwestern side of Keith Drive . and being a portion of Lots Nos. 16 and 17 in Subdivision of A. A. Green property, according to a Plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book M, at page 145, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwestern side of Keith Drive, joint front corner of Lots Nos. 17 and 18, and running thence with the line of Lot No. 18, S. 54-30 W. 150 feet to an iron pin; thence N. 35-45 W. 100 feet to an iron pin, the corner of lot conveyed to Hudson; thence with the line of said lot, N. 54-30 E. 150 feet to an iron pin on the Southwestern side of Keith Drive; thence with said Drive, S. 35-45 E. 100 feet to the beginning corner.
