All that certain parcel or lot of land situated on the north side of Memorial Drive Extension (Highway No. 110 leading from Greer to Oneal). in Chick Springs Township, Greenville County, State of South Carolina, designated as Lot No. 2 of the Property of W. Dennis Smith according to survey and plat by H.S. Brockman, Registered Surveyor, dated April 5, 1955, recorded in Plat Book FF, page 294, R.M.C. Office for Greenville County, and having the following courses and distances to wit:

BEGINNING at an iron pin on the north side of said Memorial Drive Extension, corner of Lots Nos. 1 and 2, and running thence along line of same, N. 26.40 E. 200 feet to an iron pin; thence N. 63.30 W. 100 feet to an iron pin, corner of Lot No. 3; thence along line of same, S. 26.40 W. 200 feet to an iron pin on north side of said Drive; thence along same.
