SEND GREETING:

WHEREAS, we the said Carroll S. McJunkin and Lura Ellen McJunkin

in and by our certain promissory note in writing of even date with these Presents, are well

and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of

Two Thousand and No/100 - - - - - (\$ 2000.00) Dollars,

with interest from the date hereof at the rate of seven per cent (7 %) per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of

Thirty-two and No/100 - - - - - (\$ 32.00) dollars

McJunkin and Lura Ellen McJunkin, in consideration of the said debt and sums of money aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to us the said mortgagor in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. BEGINNING AT AN Iron pin on the East side of Walnut Lane, front corner of Lots Nos. 3 and 4; thence with Lot No. 3, N. 86-45 E. 180 feet; thence N. 3-15 W 100 feet to an iron pin on line of Lot No. 5; thence with line of said lot, S 86-45 W 180 feet to an iron pin on Walnut Lane; thence with said Lane, S 3-15 E. 100 feet to the beginning.
