E., August 4, 1954, recorded in the R.M.C. office for Greenville County in Plat Book EE, at page 1, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southwestern side of River Street, joint front corner of Lots 8 and 9, and running thence along the joint line of said lots, S. 67-22 W. 275.3 feet to an iron pin on the east bank of the Reedy River; thence along the east bank of the Reedy River, S. 8-14 E. 64.7 feet to an iron pin in the center of a 10-foot drainage easement; thence along the center of said 10-foot drainage easement, N. 67-22 E. 297.6 feet to an iron pin on the southwestern side of River Street; thence along the southwestern side of River Street, N. 26-31 W. 63.1 feet to the point of beginning; being the same conveyed to me by David U. Mauldin by deed of even date herewith, not yet recorded."
