MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Evie H. Plumbley (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Bank of Travelers Rest, Travelers Rest, S. C. (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Seventeen Hundred Fifty and No/100 DOLLARS (\$1750.00),

with interest thereon from date at the rate of Six per centum per annum, said principal and interest to be repaid: \$40.00 on October 1, 1955, and a like payment of \$40.00 on the 1st day of each month thereafter until paid in full, with interest thereon from date at the rate of Six per cent, per annum, to be computed and paid semi-annually in advance

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, containing 1.6 acres, situate on the Northern side of State Highway # 11, and bounded now or formerly by Allie Bowers Sloan, on the West, Mildred Pruitt on the North, Cora Harrison on the East, and State Highway on the South, and being more particularly described as follows:

"BEGINNING at a stone in the old road known as dividing water road (now State Highway # 11) on Allie B. Sloan's line and running thence with her line, N. 13-00 W. 503 feet to an iron pin; thence N. 22-00 W. 35 feet to a stake in old road leading to the George Odom House; thence N. 86-00 E. 122 feet to a point in road marked by an iron pipe on the East bank of road; thence S. 24-55 E. 239.5 feet along the road as the line and S. 3-25 W. 300 feet along the road as the property line to a point in the Old Highway # 11; thence N. 85-00 W. 90 feet to the beginning corner. Being the same premises conveyed to the mortgagor by Cora Harrison by deed recorded in Volume 516 at Page 311."

ALSO, "All that other tract of land in Saluda Township, on the Southern side of Tigerville Road, and on the Eastern side of Dividing Water Road, having the following metes and bounds, to-wit:

"BEGINNING at a point at the Southeastern corner of the intersection of Tigerville Road and Dividing Water Road, and running thence with the Tigerville Road, S. 52 E. 111 feet to a point; thence S. 20-23 W. 300 feet to a point; thence S. 69-30 W. 23 feet to Dividing Water Road; thence with said Road, N. 11-30 W. 107 feet to beind in said Road; thence with said Road, N. 15-50 E. 337 feet to the beginning corner. Being the same premises conveyed to the mortgagor by Annie Lee Turner by deed to be recorded."

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
