"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

Chick Springs Township, School District 285, in the City of Green, on the North side of West Poinsett Street (formerly National Highway No. 29), being shown and described as Lot No. 36 on a plat of property of the W.H. Brockman Estate, prepared by Dalton and Neves, Engineers, June 1926, recorded in Plat Book H at page 132, and having the following courses and distances, to-wit:

BEGINNING at a stake on the Northern edge of West Poinsett Street, at its junction with Fleming Drive (formerly Park Avenue), and running thence with the Northern edge of West Poinsett Street, N 78-00 W 100 feet to a stake, joint front corner of Lots Nos. 36 and 37; thence as dividing line between said lots, N 12-00 E 175 feet to a point on line of Lot No. 35; thence with the line of Lot No. 35, S 78-00 E 100 feet, more or less, to a point on the Western edge of Fleming Drive, joint corner Lots Nos. 35 and 36; thence with the Western edge of Fleming Drive, S 12-00 W 175 feet to a stake on the Northern edge of West Poinsett Street and point of beginning.
