Oliver N. Evans and Cathryn F. Evans of

WHEREAS, the Mortgagor is well and truly indebted unto

organized and existing under the laws of South Carolina, a corporation  
called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which  
are incorporated herein by reference, in the principal sum of Nine Thousand and no/100  
Dollars (\$ 9,000.00 ), with interest from date at the rate of four and one-half per centum  
(. 4 1/2 %) per annum until paid, said principal and interest being payable at the office of C. Douglas  
Wilson & Co. in Greenville, S. C.  
or at such other place as the holder of the note may designate in writing, in monthly installments of  
Fifty and 04/100 Dollars (\$ 50.04 ),  
commencing on the first day of November, 19 55, and on the first day of each month there-  
after until the principal and interest are fully paid, except that the final payment of principal and interest,  
if not sooner paid, shall be due and payable on the first day of October, 19 80.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better  
securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three  
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing  
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,  
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its  
successors and assigns, the following-described real estate situated in the County of Greenville,  
State of South Carolina:

All that certain piece, parcel or lot of land, with the buildings and improve-  
ments thereon, lying and being on the southwesterly side of Charlotte Street, in  
the City of Greenville, S. C., being shown as Lot No. 11 on the plat of the proper-  
ty of G. DeWitt Auld as recorded in the RMC Office for Greenville County, S. C. in  
Plat Book "J", page 211, said lot fronting 70 feet on the southwesterly side of  
Charlotte Street and having a depth of 167.1 feet on the northwesterly side, a  
depth of 164.1 feet on the southeasterly side, and being 69.8 feet, more or less,  
across the rear.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-  
ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be  
had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter  
attached to or used in connection with the real estate herein described.

assigns forever.
