All that piece, parcel or lot of land situate, lying and being on the East
side of Robin Hood Road, in the City of Greenville, in Greenville County,
South Carolina, being shown as Lot 41 on plat of Sherwood Forest, made by
Dalton & Neves, Engineers, August 1951, revised through June 1953, recorded
in the R. M. C. Office for Greenville County, S. C., in Plat Book "GG", at
pages 70 and 71, and having according to said plat, the following metes
and bounds, to wit:

BEGINNING at an iron pin on the East side of Robin Hood Road at joint front
corner of Lots 40 and 41, and running thence along the line of Lot 40,
N. 62-36 E. 161.5 feet to an iron pin; thence S. 12-07 E. 92.7 feet to an
iron pin; thence along the rear line of Lots 42, 43 and 44 S. 57-41 W. 157
feet to an iron pin on the East side of Robin Hood Road; thence with Robin
Hood Road N. 13-41 W. 48.8 feet to an iron pin; thence still with Robin
Hood Road N. 19-26 W. 56 feet to the beginning corner.
