NOW, KNOW ALL MEN, That we, the said Franklin D. Kellett and Bobbie Jean Kellett in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to us in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Bank of Piedmont, its successors and assigns forever;

ALL that piece, parcel or lot of land in Oaklawn Township, Greenville County, State of South Carolina, containing 1.86 acres, more or less, and being described as follow:

BEGINNING at the Southwest corner, same being in the center of proposed Pine Grove Avenue; thence North 21-15 East 262 feet 3 inches to iron pin, new corner; thence South 85-30 East 304 feet to nail in road; thence along said road, South 13-19 East 194 feet 6 inches to nail in Pine Grove Avenue; thence along center of proposed Pine Grove Avenue, South 86-30 West 442 feet 2 inches to the beginning corner.
