WHEREAS, the Mortgagor is well and truly indebted unto Citizens Lumber Company

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Eighty-five Hundred and No/100 -

DOLLARS (\$ 8500.00),

with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid: PAYABLE: \$100.00 on the 2nd of January, 1956, and a like payment of \$100.00 on the 2nd day of each month thereafter until paid in full, with interest thereon from date at the rate of six (6%) per cent. per annum, to be computed and paid monthly

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Ward 6 of the City of Greenville, being described as follows:

"BEGINNING at an iron pin on Green Avenue, corner of lot now or formerly owned by A. W. Hill, running thence with Green Avenue S. 29 W. 29½ feet to an iron pin in corner of lot now or formerly owned by Emmett; thence with line of his lot S. 71 E. 151 feet to an iron pin; thence with line of lots now or formerly owned by M. B. Leach and Mrs. Hattie McGee, N. 29 E. 69½ feet to an iron pin in line of lot now or formerly owned by A. W. Hill; thence with the line of said lot N. 67 W. 151 feet to the beginning corner. Containing 11,000 square feet, and being the same premises conveyed to the mortgagor by C. W. Cooley by deed recorded in Volume 290 at Page 79.
