according to the conditions of the said Note and also in consideration of the sum of ONE DOLLAR  
to us in hand well and truly paid by the said R. H. Stowe and Clara H. Stowe  
at and before the sealing and delivery of these presents the receipt whereof is hereby acknowledged,  
have granted, bargained, sold and released, and by these Presents DO GRANT, BARGAIN, SELL and  
RELEASE unto the said Albert Lewis Campbell and Annie Campbell, their heirs  
and assigns forever: the following:

Piece, parcel or lot of real estate, lying and being in Chick Springs  
Township, County of Greenville, State of South Carolina, and known  
as lots number one (1) and two (2) on a plat of the W. E. Dill estate,  
made by S. C. Meen, surveyor, dated April, 1940, and recorded in the  
R. M. C. Office for Greenville County in plat book J page 199, and  
having the following metes and bounds according to said plat.  
Beginning at a point on the North side of Super Highway No. 29  
about two miles West of Greer, S. C., and running 50 feet each along  
the North side of said highway, and running back in a northerly  
direction in parallel lines to a depth of 225 feet, and being 50 feet  
each on the rear, for a more complete description as to metes and bounds
