TRACT NO. I:

All that certain piece, parcel or lot of land lying in the City of Rock Hill, County of York, State of South Carolina, with buildings thereon located on the northern side of East White Street, and having the following courses and distances: Beginning at a stake on White Street, now or formerly Julius Friedheim corner; running thence N. 25 E. 104 feet to a stake on Southern Railway right-of-way; thence E. 50' 4" to stake on R. E. Melton's line; thence with Melton's line S. 25 W. 96 feet to stake on White Street; thence with White Street 50 feet to the beginning, containing 5000 square feet, more or less and being one of the lots described in the deed from Hannah S. Kellar to U. M. Pursley, recorded in book 47, page 81; and being the identical lot described in the deed from James Adkins and wife, Cora N. Garrison to Coble Dairy Products, Inc. of South Carolina, recorded in Book 147, page 116 in the Office of the Clerk of Court of York County, South Carolina.

TRACT NO. II:

All that certain piece, parcel or lot of land lying, being and situate in the City of Rock Hill, County and State aforesaid; beginning at a stake on White Street, R. E. Melton's corner, and running thence N. 25 E. 88 feet to a stake on Southern Railway right-of-way; thence with right-of-way E. 50 feet 4 inches to stake on W. G. Stevens and J. L. Phillips line; thence S. 25 W. 80 feet to stake on White Street; thence with White Street 50 feet to the beginning, containing 4200 square feet, more or less, and being the identical property conveyed to W. G. Boatwright by Marshall Realty Company by deed dated April 29, 1948, recorded May 14, 1948 in Book 138, page 178, and to Coble Dairy Products Incorporated of South Carolina by W. G. Boatwright by deed dated February 11, 1953, recorded in Book 190, page 412.

TRACT NO. III:
