TRACT NO. II:

That certain lot or parcel of land lying in Black Walnut District of Halifax County, Virginia, on the south side of Highway No. 58, about one mile from the Town of South Boston, and more particularly described as follows by survey of E. R. Farmer, Surveyor: Beginning at an iron pin on the said Highway at the corner of lot of W. L. Thomas; thence off the highway S. $16\frac{1}{2}$ E. 196 feet to an iron pin at the corner of a shed at the rear corner of Thomas' lot; thence N. 83 E. 210 feet, more or less, along the line of Tract No. I above described to the southeast corner of Lot No. 12 as shown on the Stebbins and Lawson map; thence N. $11\text{-}\frac{3}{4}$ W. 275 feet, more or less, to an iron pin on the line of Highway No. 58; thence along the highway S. $60\frac{1}{2}$ W. 215 feet to the iron pin at the point of beginning. The said parcel of land is designated on map of the Stebbins and Lawson property recorded in the Clerk's Office of Halifax County in Plat Book 1, page 88, as Lots Nos. 11 and 12, except that the northern line of the original lots has been altered by the moving of the highway in a southerly direction taking off a part of the northern ends of the said Lots 11 and 12; it being intended hereby to convey all of the said Lots 11 and 12 remaining on the south side of the said highway No. 58, as now located, and as indicated by the said iron pins hereinbefore referred to. The property hereby conveyed is a part of the property conveyed to Carrie N. Tuggle by the following conveyances: An undivided one-half interest by James S. Easley, Trustee, dated May 12, 1938, recorded in the Clerk's Office of Halifax County in Deed Book 157, Page 168; and undivided one-fourth interest by V. L.
