WHEREAS, the Mortgagor is well and truly indebted unto

Now, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

ALL that lot of land with the buildings and improvements thereon situate on the Southwest side of Elaine Avenue (formerly known as Keasler Street) near the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 20 on plat of Pinebrook, made by W. N. Willis, Engineer, March 27, 1951, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "Z", at page 148; said lot fronting 72 feet along the Southwest side of Elaine Avenue, running back to a depth of 160 feet on the Southeast side, to a depth of 160 feet on the Northwest side, and being 72 feet across the rear.
