TO ALL WHOM THESE PRESENTS MAY CONCERN:

George R. Lollis and Patricia R. Lollis (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto G. W. Strickland

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of - - - - -

One Thousand Nine Hundred Sixteen and 36/100 - - - - - DOLLARS (\$ 1,916.36), with interest thereon from date at the rate of six per centum per annum, said principal and interest to be repaid: in monthly installments of \$15.00 each on the 17th day of each month thereafter, to be applied first to interest and then to principal, with interest thereon from date at the rate of six percent, to be computed and paid semi-annually until paid in full.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southwestern corner of Douglas and Looper Streets near the City of Greenville, being Lots 97 and 98 on the plat of property of Eliza T. Looper from a plat recorded in Plat Book "H" at Pages 159-160, and according to a survey made by J. C. Hill, January 7, 1956, described as follows:

"BEGINNING at a stake at the southwestern corner of Looper and Douglas Streets and running thence with the southern side of Douglas Street S. 72-30 W. 100.04 feet to a stake at corner of Lot 99; thence with the line of said lot S. 18-40 E. 147.7 feet to a stake; thence N. 71-20 E. 100 feet to a stake on Looper Street; thence with the western side of Looper Street N. 18-40 W. 145.4 feet to the beginning corner."

Being the same property conveyed to the mortgagors by the mortgagee by deed recorded herewith.

It is understood and agreed that this mortgage is junior in lien to a mortgage held by Independent Life & Accident Insurance Company in the sum of \$9000.00 of even date.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
