SEND GREETING:

Whereas, I, the said David Ray Phillips in and by my certain promissory note in writing, of even date with these Presents, am well and truly indebted to Farmers Bank of Simpsonville in the full and just sum of Eight Hundred and No/100 -- (800.00) Dollars

, to be paid \$20.00 one month after date hereof and a like payment of \$20.00 on each succeeding month thereafter until paid in full with interest being figured first and balance to apply on principal.

, with interest thereon from date at the rate of 6 per centum per annum, to be computed and paid monthly until paid in full; all interest not paid when due to bear

All that certain piece, parcel or lot of land lying and being situate in Fairview Township, Greenville County, and State of South Carolina, on the northwest side of a county road leading from Fairview to Fountain Inn, and containing 1.30 acres, more or less, and being the same lot of land conveyed to David R. Phillips by W. A. Henderson and others by their deed dated Jan. 31, 1955 and recorded in the office of the R. M. C. for Greenville County, S. C. in Deed Book 518, page 357. It begins at an iron pin in the center of a County Road leading from Fairview to Fountain Inn at corner of property of J. B. Wasson and runs thence along the west line N. 16-45 W. 356 ft. to an iron pin; thence N. 73-15 E. 127 ft. to a pin; thence S. 16-45 E. 355.6 ft. to a pin in the center of the County Road; thence along the center of that road S. 18-21 W. 221 ft. to the beginning.
