NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina: in the City of Greenville, being known as lot no. 28 on plat of Essex Court made by Dalton & Neves dated May, 1949 and recorded in the R.M.C. Office for Greenville County in Plat Book W at Page 31 and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the eastern side of Essex Court, at the joint front corner of lots nos. 28 and 29, which iron pin is situate 555 feet north of the intersection of Essex Court and a County Road and running thence along the eastern side of Essex Court, N 3-45 W, 62 feet to an iron pin, corner of lot no. 27; thence with the line of lot no. 27, N 86-15 E, 114.6 feet to an iron pin, rear corner of lot no. 27; thence S 5-52 E, 62 feet to an iron pin, rear corner of lot no. 29; thence with the line of lot no. 29, S 86-15 W, 116.9 feet to the point of beginning.
