WHEREAS, Mortgagor is indebted to Mortgagee for money loaned, to secure the payment of which Mortgagor has exe-

of all the covenants, conditions, stipulations and agreements herein contained, does by these presents grant, bargain, sell and
release to Mortgagee, its successors and assigns, the following described real estate situated ~~in~~ near the City
of Greenville, Greenville County, South Carolina:

ALL that lot of land with the buildings and improvements thereon,
situate on the Northeast side of Berryhill Road, near the City of Green-
ville, in Greenville County, South Carolina, being shown as Lot 4 of
Section 2 of Lake Forest on plat thereof made by Piedmont Engineering
Service in March, 1954, said plat recorded in the R.M.C. Office for
Greenville County, S. C., in Plat Book "EE", at pages 70 and 71, and
having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northeast side of Berryhill Road at
joint front corner of Lots 3 and 4 and running thence along the line of
Lot 3, N. 56-14 E., 145 feet to an iron pin; thence S. 50-20 E., 103.1
feet to an iron pin on the Northwest side of Berryhill Court; thence
with the curve of Berryhill Court (the chord being S. 22-12 W., 58.8
feet) to an iron pin; thence continuing with Berryhill Court, S. 47-03
W., 92.4 feet to an iron pin; thence with the curve of Berryhill Court
and Berryhill Road (the chord being N. 85-23 W., 33.7 feet) to an iron
pin on the Northeast side of Berryhill Road; thence with the Northeast
side of Berryhill Road, N. 37-29 W., 125.8 feet to the Beginning corner.
