TO ALL WHOM THESE PRESENTS MAY CONCERN:

A. B. Wirt and Gladys R. Wirt (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twenty-four Hundred and No/100 - - - - DOLLARS (\$ 2400.00), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in O'Neal Township, on the east side of Greenville Road, now known as Sandy Flat Road, and adjoining lands of Crumley Estate, on the north; Bradley on the West; and lands of W. W. Glenn on the south and east, and described as follows:

"BEGINNING at an iron pin on the Crumley line and at the corner of the Bradley property in the Old road bed and running thence with said road S. 24-53 W. 176.5 feet to an iron pin in old road; thence S. 13-20 W. 137 feet to pin in old road; thence N. 83-37 E. 1195 feet to an iron pin in branch; thence down the meanders of the branch, N. 14-54 E. 247 feet to an iron pin; thence due north 204.5 feet to fence post at corner of Crumley land; thence with Crumley line S. 78-30 W. 520 feet to iron pin; thence S. 73-50 W. 660 feet to the beginning corner, containing 10 acres, more or less."

Being the same premises conveyed to the mortgagors by Deed recorded in Deed Book 516, at Page 438.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
