MORTGAGE OF REAL ESTATE

COUNTY OF Greenville

To All Whom These Presents May Concern:

We, Allister G. Smith, Helen L. Smith, and A. J. Smith, of Greenville County.

SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to **FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREENVILLE**, in the full and just sum of Ten Thousand, Eight Hundred, Thirty and No/100 - - - -

(\$ 10,830.00) Dollars, or for future advances which may be made hereunder, from time to time, up to and including the maximum amount named herein, such advances to be repaid so as to be completed within the terms of the original contract, and so long as the monthly payments set out in the note are paid according to contract, this loan shall not be deemed delinquent by reason of said advances, with interest at the rate specified in said note,

(the terms of which are incorporated herein by reference) to be repaid in installments of One Hundred, Eight and 30/100 - - - - - (\$ 108.30) Dollars

upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said **FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE**, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said **FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE**, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said **FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE**, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, within the corporate limits of the City of Greenville, being known and designated as Lot No. 35 of a subdivision known as Vista Hills, a plat of which is of record in the R. M. C. office for Greenville County in Plat Book P, at page 149, and having the following metes and bounds, to-wit:

"BEGINNING at a point on the west side of Ashton Avenue at the joint front corner of Lots 35 and 36, said point being 100 feet north of the northwestern intersection of Ashton Avenue with a county (Gilfillin) Road, and running thence S. 82-12 W. 144.7 feet to a point at the joint rear corner of Lots 35 and 36; thence N. 17-39 W. 44.4 feet to a point at the joint rear corner of Lots 30, 31, 32 and 35; thence N. 56-06 E. 184.3 feet to a point on the west side of Ashton Avenue; thence with the west side of Ashton Avenue, S. 1-50 E. 125.3 feet to the point of beginning; being the same conveyed to the mortgagors, Allister G. Smith and Helen L. Smith, by Central Realty Corporation by deed dated November 20, 1950 and recorded in the R. M. C. office for Greenville County in Deed Vol. 423, at page 441."

ALSO: "All that piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, being known and designated as Lot No. 39 of a subdivision known as Crescent Terrace as shown on plat thereof recorded in the R. M. C. office for Greenville County in Plat Book E, at page 137, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the western side of Jones Avenue, the joint front corner of Lots 38 and 39, and running thence with the western side of said avenue, S. 0-50 W. 70 feet to an iron pin, joint front corner of Lots 39 and 40; thence along the line of Lot 40, N. 89-10 W. 230.4 feet to an iron pin; thence N. 2-08 W. 70.1 feet to an iron pin, rear corner of Lot No. 38; thence with the line of Lot No. 38, S. 89-10 E. 234 feet to the beginning corner; being the same conveyed to the mortgagor, A. J. Smith, by Joseph P. Roche by deed dated July 12, 1947 and recorded in the R. M. C. office for Greenville County in Vol. 315, at page 131."
