I, Roy Manley (hereinafter referred to as Mortgagor) SEND(S) GREETING:

Cummins and Lottie Edrie Cummins (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Eleven Hundred Twenty-Five & No/100**

**August 26, 1956** DOLLARS (\$1125.00 ),  
with interest thereon from ~~date~~ at the rate of **Five** per centum per annum, said principal and interest to be repaid: **One year from date, with interest thereon from August 26, 1956, at the rate of Five (5%) per cent, per annum, to be computed and paid semi-annually.**

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as lot # 17, and the Southern one-half of lot # 15, Block B, as shown on a plat of Pinehurst, recorded in Plat Book S at Page 77, and being more particularly described as follows:

"BEGINNING at an iron pin on the Southwest side of Pinehurst Drive, at the joint front corner of lots # 17 and 19, and running thence with line of lot # 19, S. 62-23 W. 140.7 feet to an iron pin; thence N. 27-37 W. 90 feet to an iron pin in the center of lot # 15; thence with a n w line through the center of lot # 15, N. 62-23 E. 142 feet, more or less, to an iron pin on Pinehurst Drive; thence with said Pinehurst Drive, S. 26-48 E. 90 feet to the beginning corner."
